RESPONSIBILITY & RELEASE

GETAWAY WEEKEND VACATIONS, INC., 300 Marlton Pike West, Cherry Hill, NJ 08002, the tour operator trading as ADVENTURE UNLIMITED™ is hereinafter referred to as ADVENTURE within this document. ADVENTURE hereby gives notice that ADVENTURE does not own or operate any motor coaches, cruise lines, aircraft, catering facilities, hotels or attractions and that all arrangements have been made with hotels, motor coach companies, and other independent suppliers to provide you with the services purchased in the tour upon the express condition that we shall not be liable for any injury, accident, loss, damage, delay, bankruptcy, or any irregularity which may occur either by reason of defect in any vehicle or through the acts of default of any person or company engaged in providing transportation or other services. ADVENTURE DOES NOT ACCEPT ANY LIABILITY FOR THE ACTIONS OR OMISSIONS OF THE ABOVE INDEPENDENT SUPPLIERS. EACH PARTICIPANT HEREBY RELEASES ADVENTURE for losses or damages arising from physical or emotional injury, property damages, or other economic damage caused by such factors beyond ADVENTURE's control.

Because of unforeseen circumstances, ADVENTURE reserves the right to withdraw any tour or make any change, with or without notice. In the event of inclement weather, mechanical difficulties, or other events beyond the control of ADVENTURE that cause delays, it SHALL NOT BE the responsibility of ADVENTURE to pay for resulting costs and expenses to the group, including additional lodging and meals. Furthermore, it SHALL NOT BE the responsibility of ADVENTURE to reimburse the group for tour inclusions missed resulting from such delay.

Optional activities are offered as advertised unless weather or other conditions make it impossible for individuals to participate. Payment for optional activities must be made in cash at the location. Many activities are subject to a minimum participation as dictated by the operator of the activity and available transportation. Prices for all optional activities are subject to change with or without notice.

It is the responsibility of the Group Organizer to assure that each group member receives the proper "Statement of Responsibilities, Release, Terms and Conditions" and other policies as represented by ADVENTURE.

ADVENTURE retains the right to videotape and photograph any or all events listed on this tour and use such videotapes/photographs to produce promotional materials that would be used to promote similar events on the internet, brochures and promotional DVDs. Any person attending this event releases ADVENTURE from any claim from their image appearing in such advertisements.

Each Group Organizer assembles his or her own group. ADVENTURE does not have the responsibility to screen individual participants and is not responsible for any situations that arise as a result of disagreements between participants.

This tour is governed by and construed in accordance with the laws of the State Of New Jersey. In the unlikely event a dispute cannot be amicably resolved and a court action is necessary, it is agreed that all disputes and demands shall be heard in Camden County, NJ.

RESERVATIONS, PAYMENTS & CONFIRMATIONS

The Group Organizer has the obligation of sending full names, rooming requirements and money in accordance with the dates on the Group Tour Agreement (GTA). The GTA is the tour contract between the Group Organizer and ADVENTURE. Collection and disbursement of all group funds, and all communication with ADVENTURE is solely the Group Organizer's responsibility. The Group Organizer acts solely as a representative of the group and is NOT an employee, representative or agent of ADVENTURE. By signing up for the tour, you waive your individual rights and agree that your Group Organizer, or travel agency, is empowered to act on your behalf and make any change in the tour that he or she feels appropriate.

Space is held for contracted reservations upon the timely receipt of deposits and names at ADVENTURE in accordance with the dates in the GTA. Final arrangements and confirmations are only made for contracted reservations upon receipt of the complete rooming/bus list and final group payment at ADVENTURE in accordance with the dates set forth in the GTA.

Whenever the Group Organizer has complied with providing ADVENTURE the payments and rooming/bus lists as per the dates on the GTA, and in the unlikely event ADVENTURE can not provide the contracted destination, ADVENTURE will provide a full refund as its only liability.

TIME IS OF THE ESSENCE: In the absence of the arrival of timely payments and rooming/bus lists at ADVENTURE as per the contracted dates on the GTA, space and tickets (including, but not limited to theatre and/or attraction tickets) held are released and are subject to cancellation as per the terms in the section of this document called CANCELLATIONS.

All conversations and arrangements regarding the tour are conducted between the Group Organizer and ADVENTURE. All changes requested by the Group Organizer concerning time and space reserved are not applicable, unless confirmed in writing by ADVENTURE.

There is a \$35 charge for each returned check.

ACCOMMODATIONS

The hotel's front desk personnel make the room assignments and, based upon availability, they will attempt to fulfill requests for single or double-bedded and smoking or non-smoking rooms. Per person prices are stipulated for the number of people in a room, not the number of beds. Double accommodations (2 people per room) does not necessarily mean that the room contains two beds. Rooms do not have more than 2 beds. Many hotels cannot accommodate 5 people per room; therefore, requests for quint occupancy (5 people per room) cannot be assumed unless confirmed in writing by ADVENTURE. Requests for roll-a-way beds or cots will result in additional cost to the occupants of the room.

CHILDREN'S RATES

When available, this rate is based upon a child or children, under 16 years old, sharing the room with either: a single adult paying the full single (1 per room) rate; two adults each paying the full double (2 per room) rate; or three adults each paying the full triple (3 per room) rate. Up to 4 people, including children, may occupy a room. There is a reduced charge for Infants (2 and under).

CANCELLATIONS

Cancellations received more than 60 days prior to trip departure are subject to a processing fee of \$75.00 per person as liquidated damages. Cancellations received between 36 and 59 days prior to trip departure are subject to a processing fee of \$150 per person as liquidated damages. Cancellations received within 36 days prior to trip departure are subject to a 100% cancellation fee of the published tour price as liquidated damages. Notification of any cancellation must be sent in writing and shall be effective on the date received from your Group Organizer at ADVENTURE. REPLACEMENTS: If a replacement is provided for a cancelling individual, there is no cancellation or processing fee for that cancellation. A replacement for a cancelled individual must occupy the same room space. If the group does not provide a replacement for a cancelling individual who has not paid the full tour price, the remaining occupants in that room shall be obligated to pay for their actual room occupancy.

REFUNDS

APPLICABLE REFUNDS WILL BE SENT TO YOUR GROUP ORGANIZER. ACCEPTANCE OF THE REFUND BY THE GROUP ORGANIZER RELEASES ADVENTURE FROM ANY AND ALL CLAIMS BY THE GROUP AND/OR ITS INDIVIDUAL PARTICIPANTS.

Refunds or allowances will not be made for portions of the tour that are unused for any reason whatsoever. Furthermore, in the event of a cancellation all tour inclusions reserved for the cancelling party(ies) shall become the property of ADVENTURE to do with as it chooses without further obligation to the group.

The destination hotels and transportation companies, in addition to all other providers of services, reserve the right to remove individuals or an entire group from the tour, without refund, if persons within the group are engaged in illegal or disorderly conduct.

TRANSPORTATION

Whenever the tour includes motor coach transportation, the published tour prices are based upon the group providing a minimum of 52 passengers per motor coach. If the group has less than the 52 minimum they are required to pay an "empty seat surcharge" for the unsold seats below the 52 minimum. ADVENTURE will provide the price of the empty seat surcharge for the particular destination upon request.

If the Group Organizer desires, ADVENTURE will try to help the Group Organizer avoid incurring an empty seat surcharge by attempting to add passengers. No less than 21 days prior to departure, ADVENTURE requires written authorization from the Group Organizer requesting ADVENTURE's assistance to add passengers. Please note that this is not a guarantee that ADVENTURE will be successful. Adding passengers generally results in adding other pick-up locations and pick-up time changes.

Estimated pick-up times are available for confirmation by the Group Organizer 24 hours prior to departure. It is the obligation of the group organizer to call ADVENTURE for notification of the estimated pick-up time. All pick-up times are, at best, estimates due to the various unforeseen circumstances such as; traffic, weather, mechanical difficulty and road construction.

The Group Organizer selects the pick-up location. ADVENTURE is not responsible for any costs or damages sustained resulting from the selection of pick-up location. Selected pick-up locations are accommodated for those groups that are paid in full and consist of a minimum of 23 passengers. Groups with less than 23 passengers may be required to meet at an alternate location. Rates quoted are based upon tariffs current at the time of printing and are subject to changes therein at or before final payment. Changes in pick-up location, changes or delays in pick-up times, and/or the adding of a fuel surcharge are not grounds for cancellation by the group or group participants or for any form of reimbursement.

LEGAL AGE FOR CONSUMPTION OF ALCOHOLIC BEVERAGES

There is no minimum age requirement to participate in most of these tours. It is the group's responsibility to assure that parents or legal guardians accompany individuals under 18 years of age. Each participant must be 21 years old to participate in the functions or tour inclusions that contain alcoholic beverages and to enter the casino portion (gambling area) of the hotel/resort. Each tour participant must be prepared to show 2 types of legal identification (one which must include a photograph) to gain admission into any functions or events which serve alcoholic beverages or the casino (gambling area). Each liquor licensee is under legal obligation to comply with all applicable laws and is required by law to not serve alcoholic beverages to individuals who do not meet the standard of service even though they may have paid for the alcoholic beverages inclusion as part of their tour and are not due a refund for these unused services.

BAGGAGE, TRIP CANCELLATION & OTHER INSURANCE

Free space is provided on each bus for the storage of personal belongings and baggage during transportation. The safekeeping of baggage and personal belongings is solely each participant's responsibility. Passengers are strongly advised to protect themselves with insurance. Optional cancellation, accident, health, and baggage insurance are available to protect passengers against unforeseen circumstances. Upon request, ADVENTURE will provide further information and rates. Insurance must be purchased no later than 21 days prior to departure.
